Dear President Lampe:

The purpose of this letter is to share, for your review and comment:

- (1) the Draft Environmental Assessment (EA) Report prepared by the Impact Assessment Agency of Canada (the Agency), and
- (2) the potential federal EA conditions, which will be recommended to the Minister of Environment and Climate Change for inclusion in her Decision Statement.

As you know, on August 28, 2019, the *Impact Assessment Act* came into force. The EA for the CNOOC International Flemish Pass Exploration Drilling Project (the Project) commenced in June 2017 and, as such, it will be completed under the Canadian Environmental Assessment Act, 2012 as per transitional provisions described in the Impact Assessment Act.

The Draft EA Report presents the Agency's views on the findings of the EA, including conclusions and recommendations regarding the significance of the environmental effects of the Project, technically and economically feasible mitigation measures that would mitigate any significant effects and the requirements of the follow-up program should the Project proceed.

The Draft EA Report also includes a summary of consultation with Indigenous peoples in relation to the Project during the EA process, and sets out proposed mitigation and/or accommodation measures for potential effects on Indigenous communities and potential impacts to potential or established rights.

After reviewing all comments, the Agency will revise the EA Report and potential federal conditions as appropriate before providing them to the Minister of Environment and Climate Change for consideration in taking her EA decision. The federal conditions would become legally binding on the proponent if the Minister of Environment and Climate Change issues a Decision Statement that would allow the Project to proceed.
