Cliff Grandison:

On May 31, 2022, the Impact Assessment Agency of Canada (the Agency) received your request for an extension to the three-year legislated time limit to provide the required information or studies for the environmental assessment under the *Canadian Environmental Assessment Act, 2012* (CEAA 2012) of the More Creek Hydroelectric Project (the Project).

As per subsection 181(2.1) of the *Impact Assessment Act* (the IAA), at the proponent's request, the Agency may extend the time limit by any period that is necessary for the proponent to provide the Agency with the required information or studies.

The Agency considers extensions to the legislated time limits of transitional environmental assessments continuing under CEAA 2012 in exceptional circumstances. Given that a new legislated federal assessment process has come into force, the transitional provisions under the IAA are intended for the environmental assessment of projects that can reasonably continue and be completed within or near to the statutory legislated time limit established under the IAA.

Following a review of available information, including the information submitted in your request, the Agency has determined it **will not extend the time limit**. The Agency considered the following reasons:

1. the required information or studies have not sufficiently advanced within the three-year time limit;

2. you have not demonstrated how you intend to provide the required information or studies within the requested extension in consideration of the lack of progress in the development of the Environmental Impact Statement since the Environmental Impact Statement Guidelines were issued in 2016; and
3. coordination with the provincial environmental assessment process would be best accomplished under the IAA.

As outlined in correspondence of August 13, 2019, December 17, 2020, June 18, 2021, March 15, 2022, and May 24, 2022, in accordance with subsection 181(3) of the IAA, the environmental assessment for the Project under CEAA 2012 **will be terminated** after August 28, 2022, if the required information or studies have not been provided. If this is the case, a notice informing the public of the termination will be posted on the Canadian Impact Assessment Registry.

If the environmental assessment is terminated, in accordance with subsection 7(1) of the IAA, proponents of a designated project are prohibited from carrying out any act related to the project that may cause one of the effects listed therein. If the proponent wishes to continue with the Project after the termination of the assessment, it must submit an Initial Project Description to the Agency in accordance with Section 10 of the IAA.
