Dear Mr. Kennedy:

Thank you for your letter of January 19, 2018 informing the Canadian Environmental Assessment Agency (the Agency) that Innergex Renewable Energy Inc. (Innergex) does "not intend to carry out either the Sundog or Pelican" Renewable Generation Station (RGS) Projects (Projects). Based on this information, the Agency understands the Sundog RGS and the Pelican RGS Projects, as proposed, will not proceed at this time.

On December 20, 2017, the Minister of the Environment designated these Projects as requiring environmental assessments pursuant to subsection 14(2) of the Canadian Environmental Assessment Act, 2012 (CEAA 2012). The Agency commenced the environmental assessments on January 10, 2018.

The Agency accepts Innergex's request to withdraw the Projects from the federal environmental assessment process and has terminated the environmental assessments pursuant to section 62 of CEAA 2012. Your January 19, 2018 letter and a Notice of Termination have been posted to the Canadian Environmental Assessment Registry at http://www.ceaaacee.gc.ca (Project Reference: 80145 and 80146). The Agency will also notify the potentially affected Indigenous groups about the status of the environmental assessments of the Projects.

The Ministerial Orders designating the Projects as physical activities requiring environmental assessments under CEAA 2012 remains in effect. Should Innergex decide to proceed at a later date with one or both of these Projects, the Projects will be subject to an environmental assessment under CEAA 2012. If Innergex considers proposing a different project(s) in the future, the Agency recommends that Innergex contact the Agency regarding the application of CEAA 2012 and federal environmental assessment requirements.

Please be advised that the prohibition under section 6 of CEAA 2012 continues to apply to the Projects. Under section 6, Innergex must not do any act or thing in connection with the carrying out of the designated Projects, in whole or in part, if that act or thing may cause an



environmental effect referred to in subsection 5(1) until such time that decision statements have been issued allowing the Projects to proceed.
