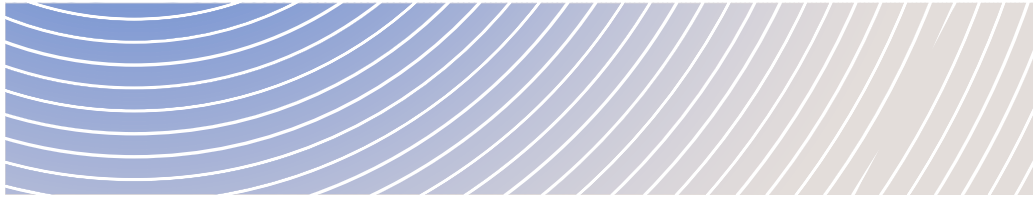

# 1. Introduction

On November 26, 2020, the Impact Assessment Agency of Canada (the Agency) determined that an impact assessment was required for the Wasamac Gold Mine Project (the Project), pursuant to section 16 of the *Impact Assessment Act* (IAA).

The Public Participation Plan, developed by the Agency, takes into account the context of the COVID-19 pandemic, to provide the best opportunities for public participation during the entire impact assessment process for the Project. This Plan may be adapted as the pandemic or the impact assessment evolves. If this is the case, the Agency will inform the public and stakeholders.

## 2. Project description

Yamana Gold is proposing the construction, operation, decommissioning and abandonment of an underground gold mine, located approximately 15 kilometres from downtown Rouyn-Noranda in the Abitibi-Témiscamingue region of Quebec. As proposed, the Wasamac Gold Mine project would have a mine life of 11 years and an ore production capacity of 6,053 tonnes per day. The Project would include the operation of an underground mine, the implementation of an ore processing plant and related infrastructure, and the development of underground infrastructure for ore and waste rock transportation as well as waste rock, tailings and overburden accumulation areas.

## 3. Objectives of public participation

The Public Participation Plan explains how to participate in the impact assessment process and provide input. The Agency has the following public participation objectives:

- Members of the public who wish to participate in the impact assessment have the opportunity to do so in an informed manner, with the necessary information.
- The Agency wishes to put in place conditions conducive to the participation of a range of people, including youth, women, seniors and groups with diverse identity profiles.
- The public participates from the outset. Its participation continues on a regular and frequent basis, at each key stage of the process.
- The public participates in the development of key documents, including the Public Participation Plan, the Tailored Impact Statement Guidelines, the proponent's Impact Statement, the Impact Assessment Report and potential conditions.

- Engagement opportunities and mechanisms, selected according to identified needs and interests, include public comment periods, in-person activities and virtual information sessions at key stages of the process.
- Comments received to date on the Project can be found on the [Canadian Impact Assessment Registry](#) (the Registry).
- The Agency informs the proponent about the concerns raised by the stakeholders; and
- Public views heard throughout the process are documented and inform decision-making.

## 3.1 Identifying stakeholders

## 3.2 Public participation tools

The Agency has identified a series of potential ways to ensure meaningful participation in the impact assessment process:

- Planned virtual presentations for public participation, including Q&A sessions;
- Virtual training on the impact assessment process and how to participate effectively during the process.
- Community meetings, in person or virtual, depending on the status of the COVID-19 health crisis;
- Public notices;
- Notices and updates on the Registry;
- Social media updates (e.g., the Agency's Twitter feed);
- Email distribution;
- Advertising in community radio;
- Publication in local newspapers; and
- Flyers distributed to local grocery stores or community centers.
