Subject: Next Steps in the Planning Phase for the Potential Federal Impact Assessment of the Proposed Upper Beaver Gold Project

On behalf of the Impact Assessment Agency of Canada (the Agency), I wish to thank Beaverhouse Indigenous Community for providing comments on the proposed Upper Beaver Gold Project (the Project) during the recent public comment period held from September 13, 2021, to October 4, 2021. Based on the input received from Beaverhouse Indigenous Community, Indigenous groups, federal authorities, provincial ministries, and the public, the Agency has developed a Summary of Issues related to the Project. The Summary of Issues has been provided to the proponent and posted to the Registry at the following link: iaac-aeic.gc.ca/050/evaluations/proj/82960#keyDocumentsTable

The Agency expects to receive the proponent's Detailed Project Description by November 12, 2021. Once received, the Agency will consider the proponent's Detailed Project Description including how the proponent plans to address the issues raised in the Summary of Issues, and will then determine whether a federal impact assessment is required pursuant to the *Impact Assessment Act*. The Agency will follow up with Beaverhouse Indigenous Community to convey the outcome of this determination and share how comments received during the comment period were taken into account.

Anticipated Timelines for the Planning Phase

In the table below, I have provided an overview of the anticipated timelines for the remaining steps in the planning phase of the Project. The timelines are in accordance with the *Information and Management of Time Limits Regulations*:
