The Agency is of the view that the Project does not warrant a referral to a review panel, after considering the factors in subsection 36(2) of the *Impact Assessment Act*. Please note that the Minister of Environment and Climate Change has until 45 days after the Notice of Commencement to make a final determination on whether to refer the impact assessment to a review panel.

The Project is now in the impact statement phase. The Agency must be satisfied that Marten Falls First Nation and Webequie First Nation (the Proponent) provided the required information and studies for the impact assessment set out in the Guidelines within three years of the Notice of Commencement.

The Agency looks forward to collaborating further with Ontario ministries to increase efficiency and certainty for all assessment participants through information sharing, joint meetings, and coordinating activities and timelines where possible, in line with the Cooperation Plan.

The Agency will keep you informed of relevant timelines and opportunities for cooperation as they occur. Within three months of the posting of the Notice of Commencement, the Proponent is expected to provide the Agency with a work plan for the impact statement phase of the Project, which the Agency will share with you.
