In the coming months, the Agency will share with you information about the next steps in the federal impact assessment process, and a summary table with the comments received during the planning phase, with the Agency's responses that describe how the comments were taken into account in finalizing the Guidelines and plans. This table also will inform the Proponent's work while preparing its Impact Statement.

The Agency is of the view that the Project does not warrant a referral to a review panel, after considering the factors in subsection 36(2) of the *Impact Assessment Act*. Please note that the Minister of Environment and Climate Change has until 45 days after the Notice of Commencement to make a final determination on whether to refer the impact assessment to a review panel.

Under subsection 19(1) of the *Impact Assessment Act*, the proponent of a designated project must provide, to the Agency's satisfaction, any information or studies required by the Agency within three years after the day on which a copy of the Notice of Commencement is posted on the Registry website.

While preparing the Impact Statement to meet the requirements outlined in the Tailored Impact Statement Guidelines for the Project, the Proponent, Marten Falls First Nation and Webequie First Nation, may request input from your municipality.

Upon receipt of the Proponent's Impact Statement for the Project, the Agency will hold a public comment period. Notification of the comment period will be sent to the contacts provided to the Agency for its public participation distribution list.
