

Please be advised we received (October 21, 2010) your report on your heritage resource impact assessment (HRIA) of this project, and mitigation of associated sites, completed under Investigation Permits #10-208 and 10-237.

As you know, seven new sites (FhNe-159 to 165) were identified during the course of the assessment, and one previously identified site was revisited. With previous HRIA results considered, 19 sites are in conflict with the new areas of development. A review of these sites determined that five sites require further investigation prior to development proceeding. These sites, FhNe-26, FhNe-27, FhNe-34, FhNe-36 and FhNf-59 were mitigated through a phase one excavation. Results of this mitigation determined that no further work is warranted. Consequently, all heritage concerns resulting from the revision/expansion of the mine have been addressed and accordingly this office has no further objection to this project proceeding as planned.
