Environmental Assessment of the Proposed KSM(Kerr-Sulphurets-Mitchell) Project

Open Houses *and* Invitation to Comment

Seabridge Gold Inc. (Proponent) is proposing to develop three low grade gold-copper deposits, located approximately 65 km northwest of Stewart, by open pit mining (proposed Project). The proposed Project would have an anticipated production of 120,000 tonnes per day over a 37 year lifespan.

The proposed Project is subject to review under British Columbia's *Environmental Assessment Act* and the *Canadian Environmental Assessment Act*.

The Proponent must obtain an environmental assessment (EA) certificate before any development can be undertaken on the proposed Project. However, prior to submission of an application for an EA certificate (Application) by the Proponent, the Environmental Assessment Office of British Columbia (EAO) must first approve the Application Information Requirements.

The Application Information Requirements will specify the detailed information to be provided by the Proponent in its Application. The EAO has now received the draft Application Information Requirements prepared by the Proponent and invites comments on this draft.

In order to provide information about the Application Information Requirements, and to receive comments from the public, the EAO invites the public to attend an **Open House**. There will be four Open Houses, to be held as follows:

At each Open House at 7 p.m. there will be a presentation by the EAO on the process with an opportunity to ask questions about the process. A second presentation will also be given by the Proponent discussing the proposed Project.

If you are unable to attend an Open House, you may still wish to make a written submission. There are 30 days for the submission of comments by the public in relation to the draft Application Information Requirements.

The comment period will begin on June 25, 2010 and end at midnight on July 26, 2010. All comments received during this comment period in relation to the Application Information Requirements will be considered.

The intention of seeking public comments is to ensure that all potential effects – environmental, economic, social, heritage and health – that might result from the Project are identified for consideration as part of the assessment process. At this stage of the process, the primary intent is to receive feedback about the information required for a comprehensive environmental assessment.

After taking public comments into account, the EAO will finalize the Application Information Requirements and issue them to the Proponent.

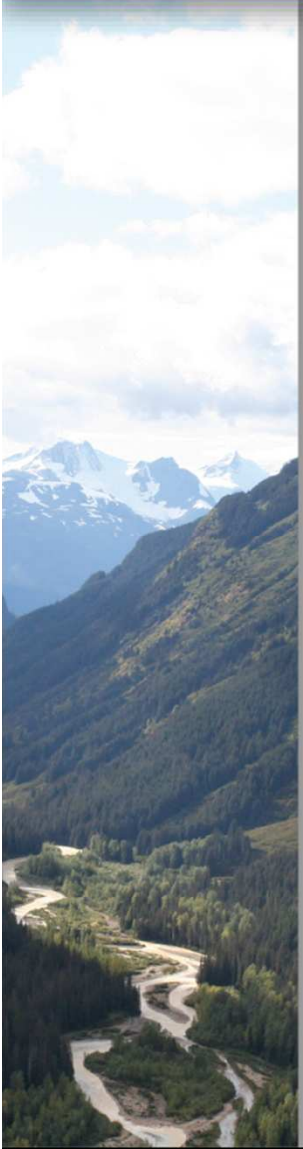

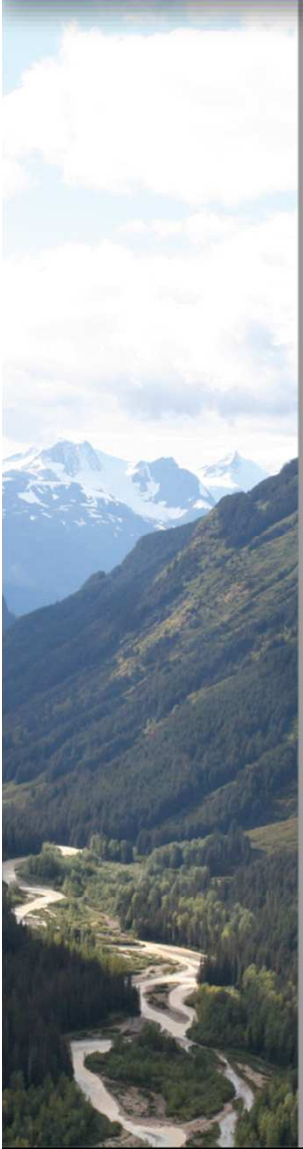
If you are unable to participate at this time, there will be an additional comment period during the Application review stage when you will also be able to provide comments to the EAO on the proposed Project.

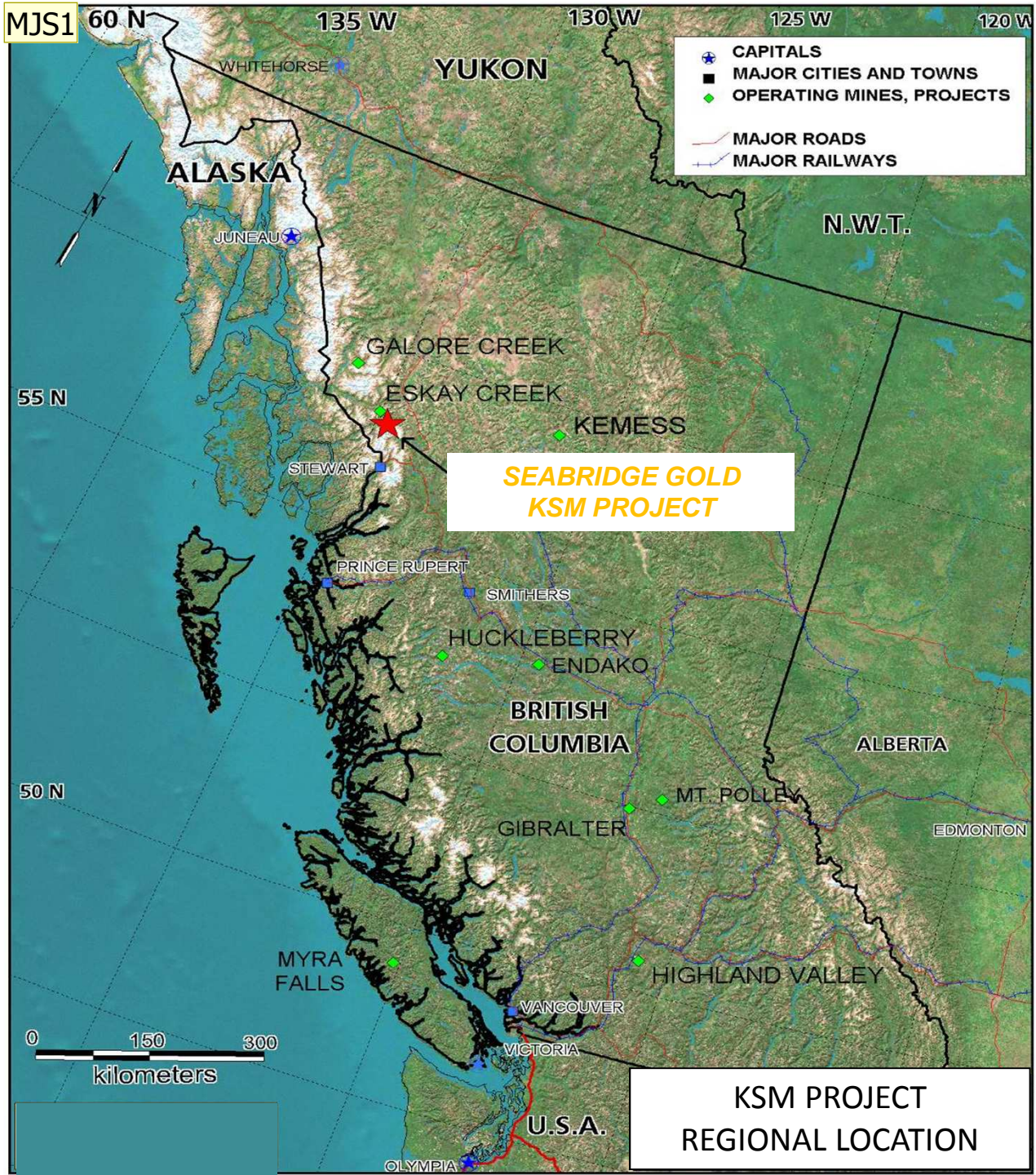

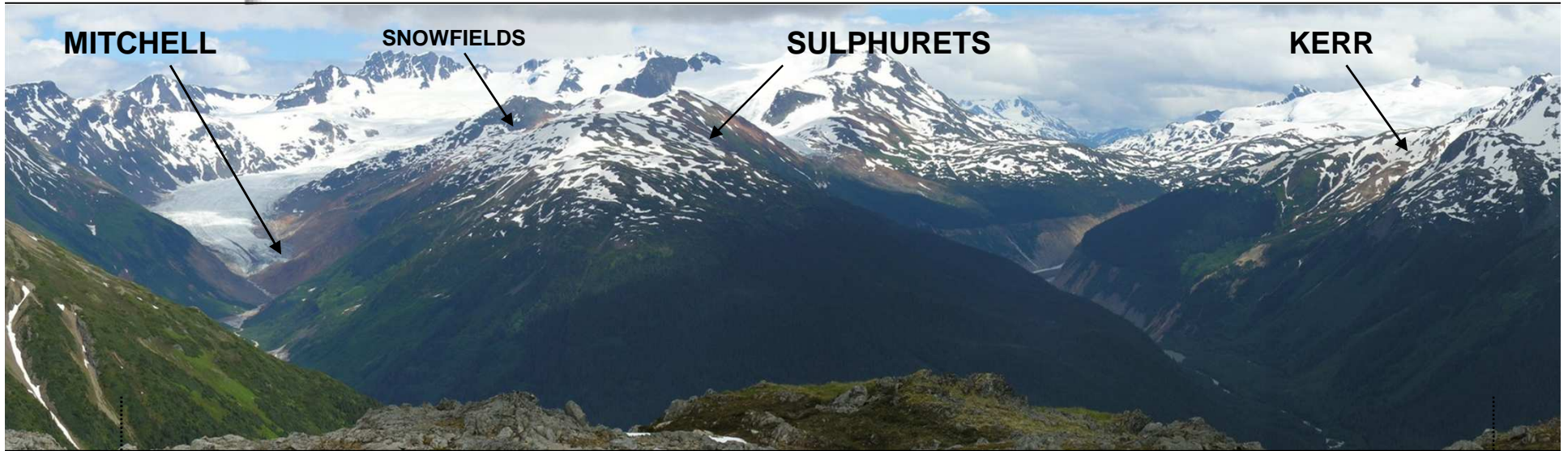

REGIONAL LOCATION**

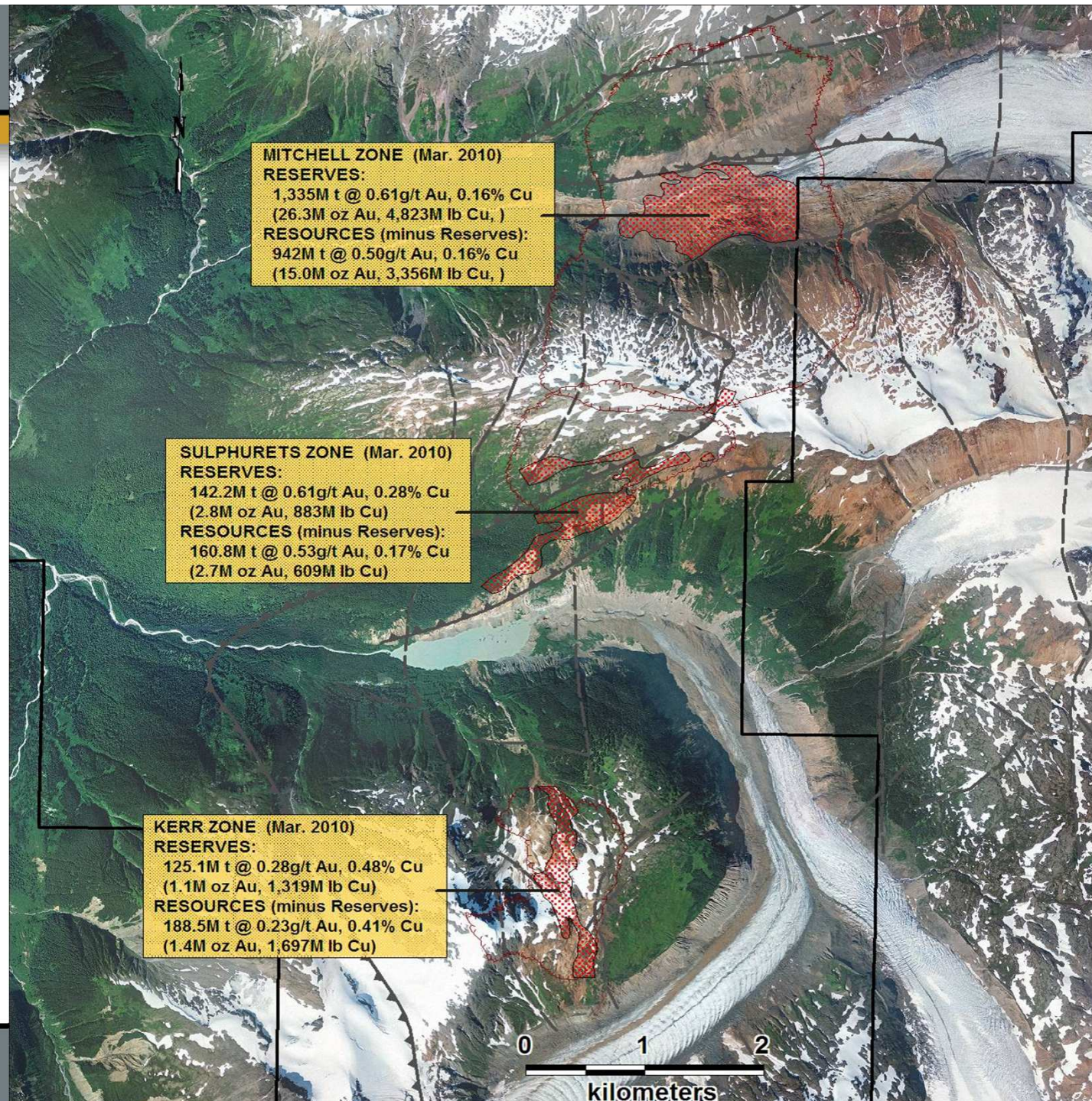

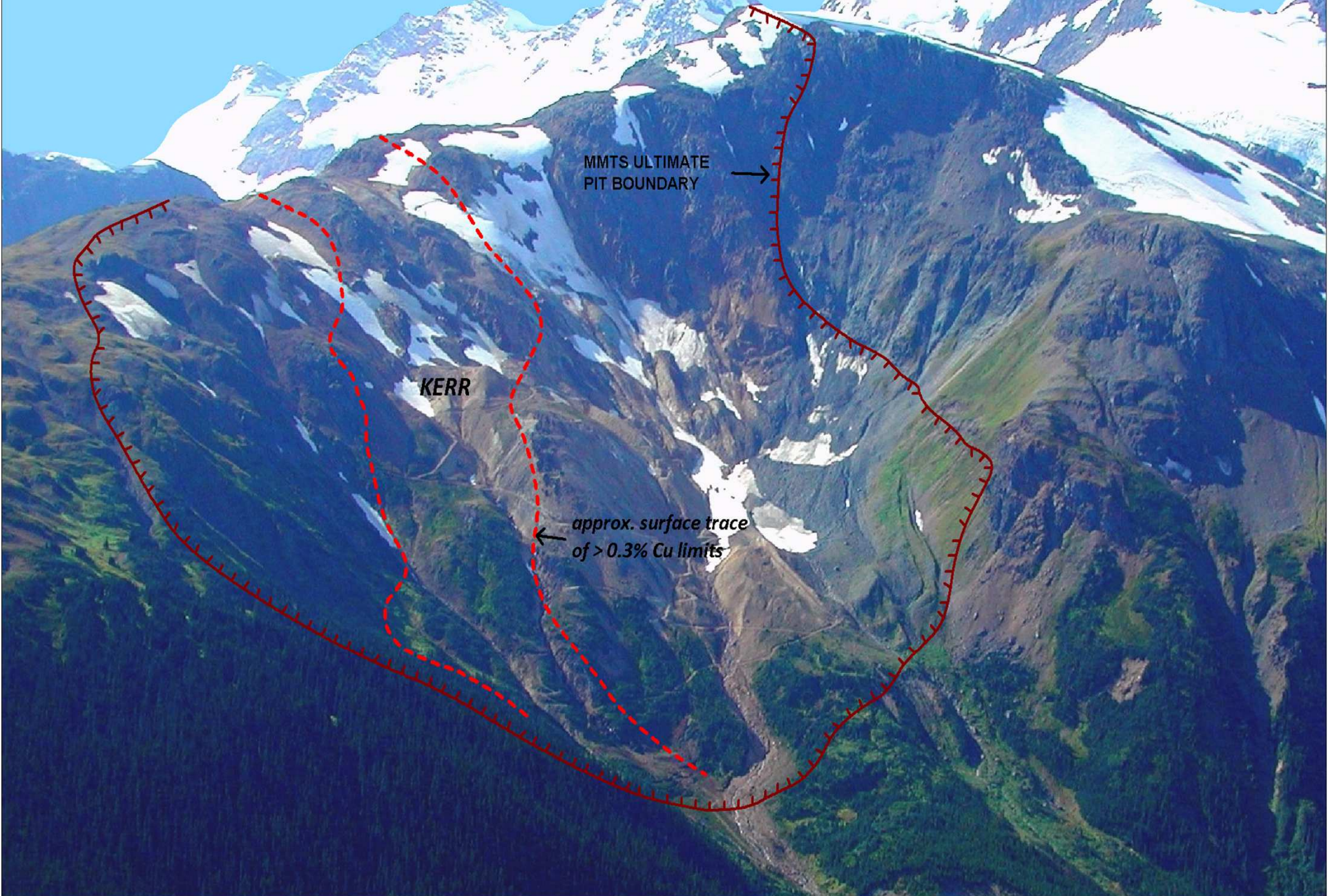

View From Sulphurets Looking South



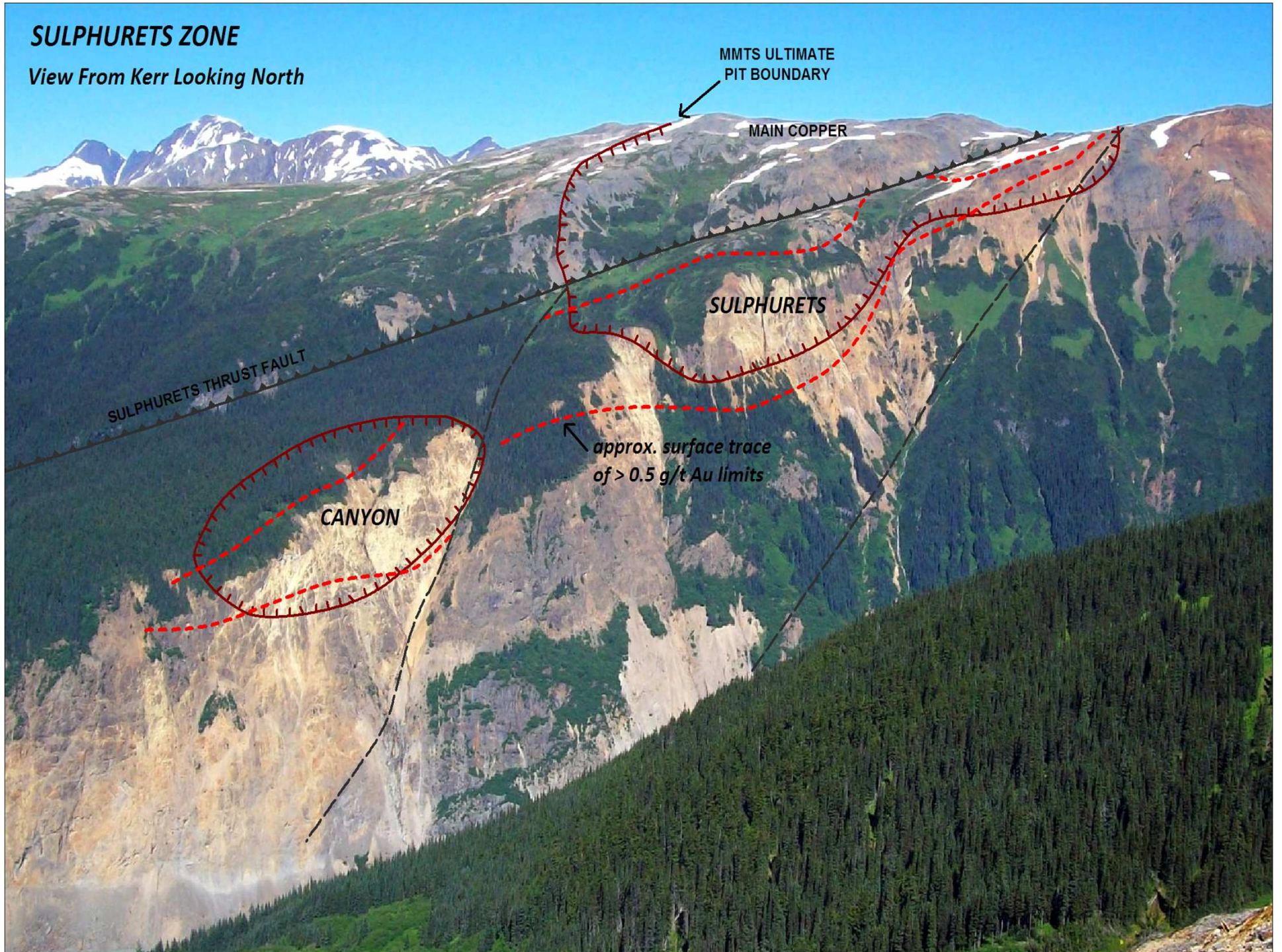

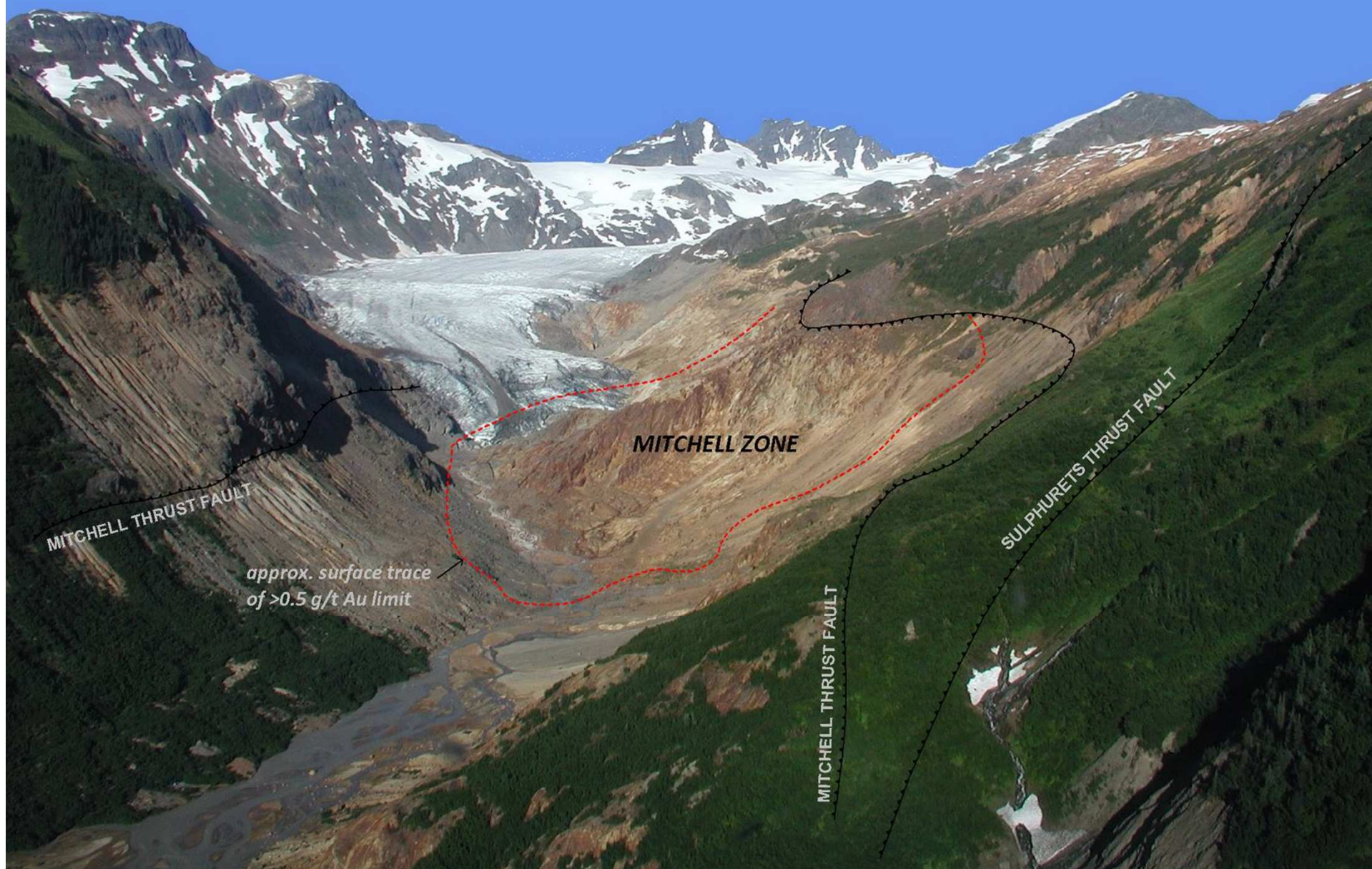

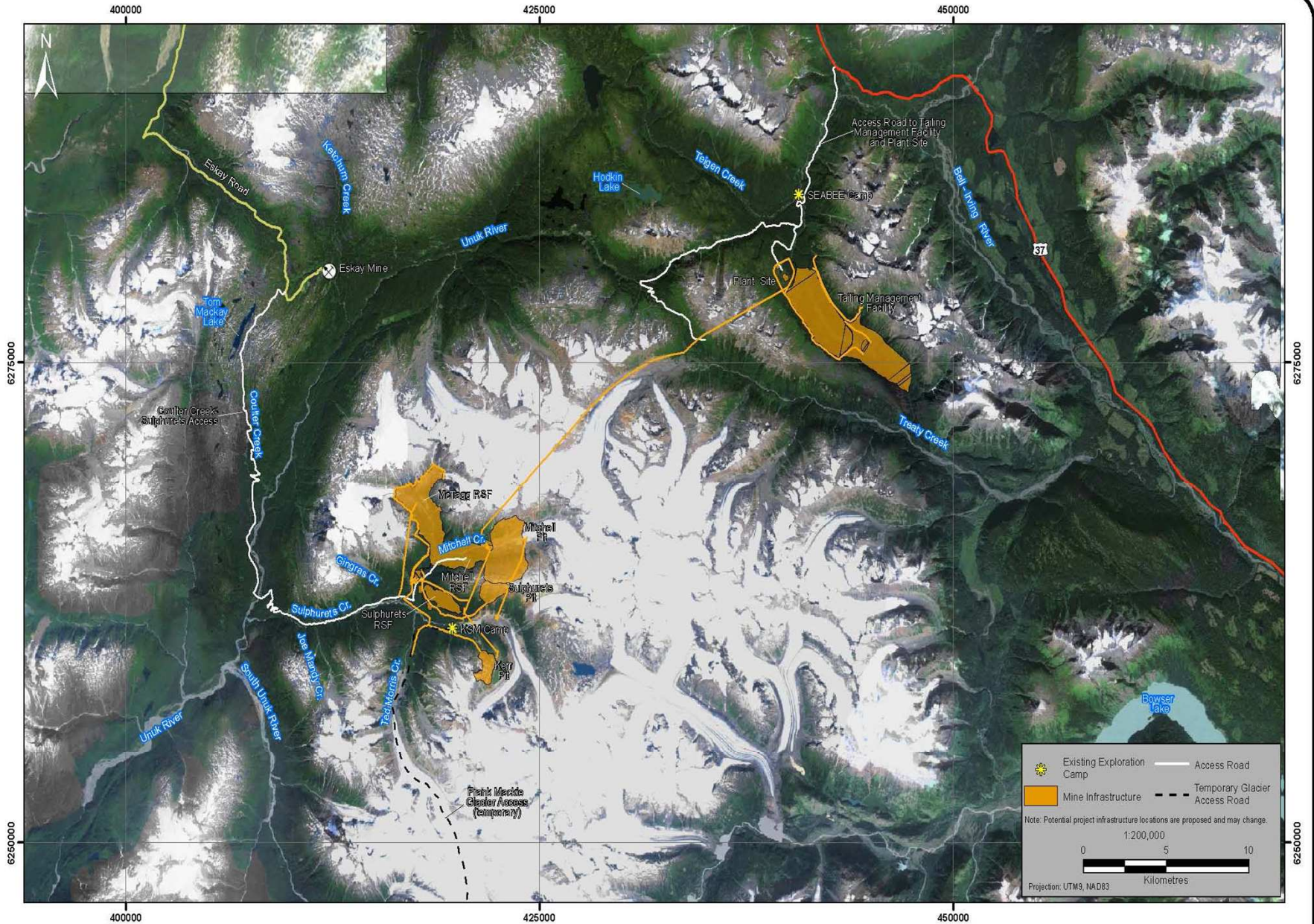
View From Kerr Looking North

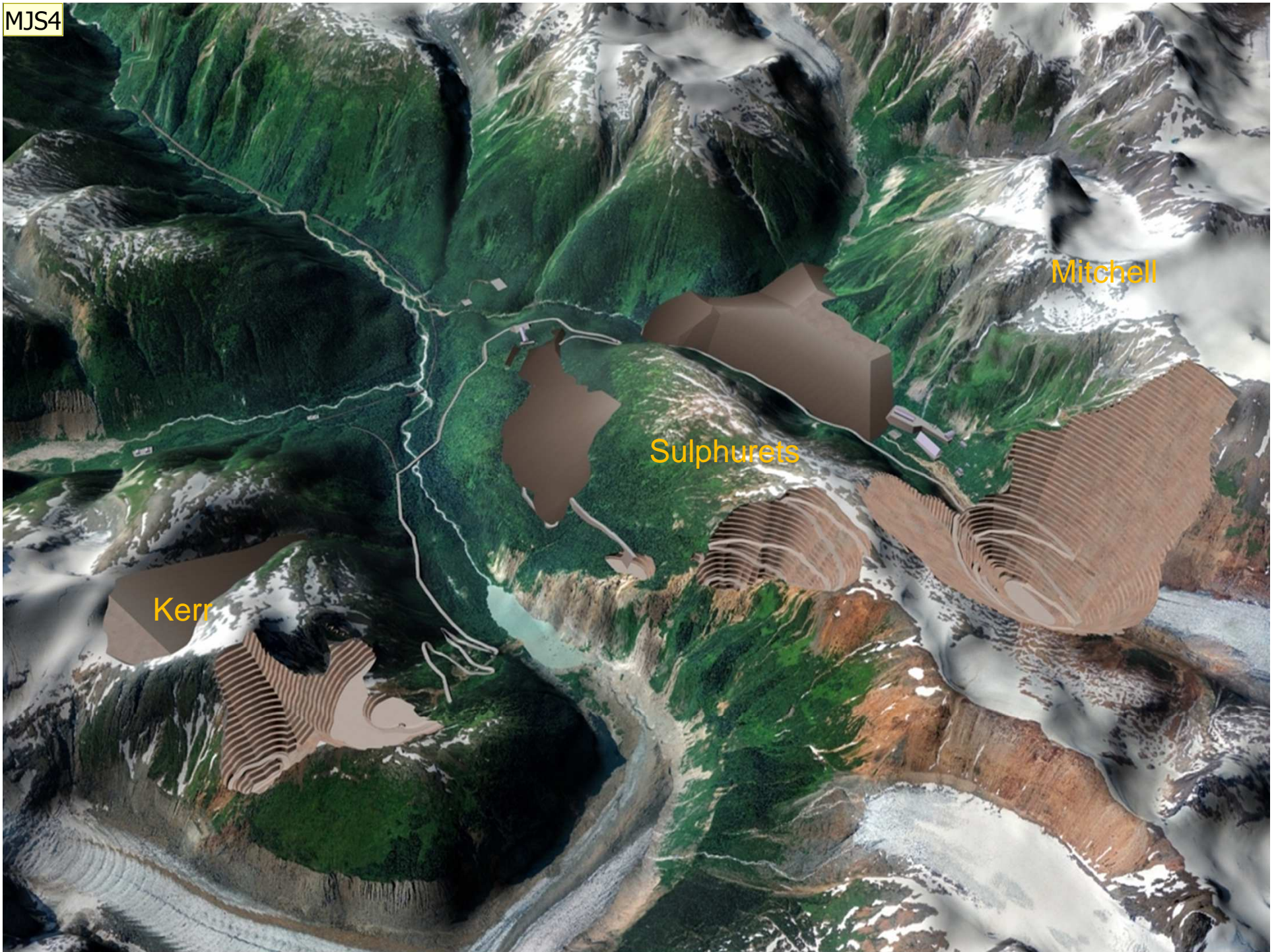


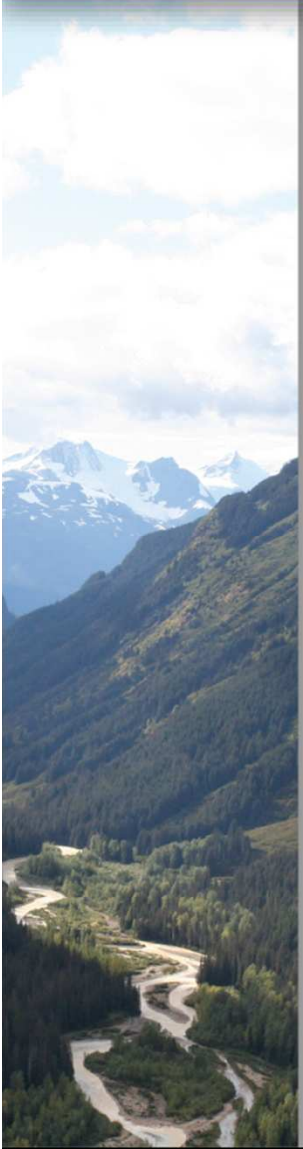

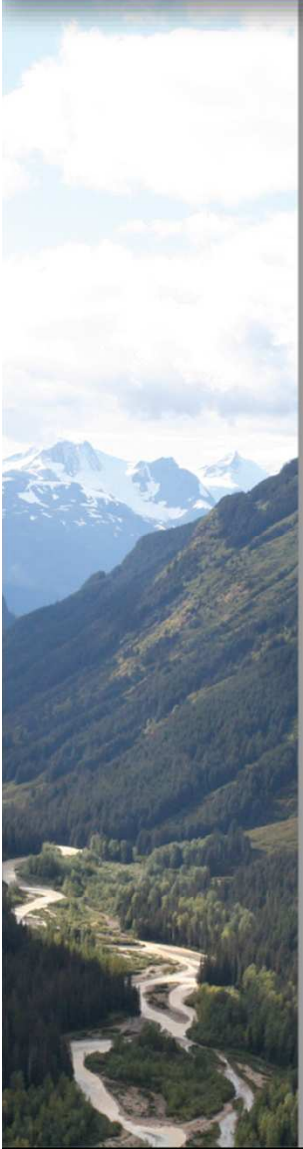
Proposed KSM Project Layout
